FEE ORDER

ORDER made in the matter of determination of fee structure for the Academic Years 2023-2024, 2024-2025 & 2025-2026:

1. In pursuance of the powers conferred upon it, the Fee Regulatory Committee (Technical) (the "Committee" for short) which is constituted under the provisions of **The Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007** ("the Act" for short) intimated all the institutions which are subject to the jurisdiction of the Committee, to submit their proposals for determining the fee structure for the block period of three years of 2023-24, 2024-25 and 2025-26 on 20/04/2023. The deadline for submission of applications/consent was 10/05/2023. The time-limit was extended till 17/05/2023 considering the requests received from several institutions from time to time. From amongst the existing institutions as on 2022-23, total 485 institutions had submitted the fee proposals in prescribed formats till the extended time-limit for raise up to aggregate 5% of the existing fee based on the notional rise granted by the Committee in accordance with their fee proposals for the years 2020-21, 2021-22 and 2022-23 subject to an upper limit of 5%. The notional rise is granted by the Committee keeping in view the acceptance of its appeal by the institutions to maintain the status quo of the then existing fee due to COVID-19 pandemic conditions. Moreover, 15 other institutions which had shown intention to raise the fee structure above 5% of the existing fee for the year 2022-23 have changed the mind afterwards and requested the Committee to allow them to submit the fee proposals for up to aggregate 5% of existing fee. The



committee accepted the requests of these institutions and as a whole total 500 institutions are included in **Appendix-I**.

2. The Proviso to Section 10(c) of the said "Act" prescribes as under: -

"Provided that the unaided professional educational college or institution may raise the fee up to five percent of existing fee for the fee block up to three years, or make any reduction in the existing fees without following the procedure as referred to in clauses (a) and (b) above. However, the unaided professional educational college or institution shall provide a "Declaration cum Undertaking" regarding the revised fee structure under this section in the form of affidavit as may be prescribed."

In view of the above provision, the Committee has granted the increase in fee structure which is not exceeding the aggregate 5% of the existing fee and has determined the fee structure for the institutions listed in **Appendix-I** hereto for the block period of three years commencing from the year 2023-24 which is subjected to the following conditions:

- i. The fee structure indicated above is the fees in Rupees per annum per student.
- ii. The fee structure determined by the Committee shall be binding for a period of three years. The fee so determined shall be applicable to the students admitted in that academic year and shall not be revised till the completion of his/her professional course in the same institution.
- iii. The notional rise as mentioned in Para-1 of this order is only for the limited purpose of fixing the base for the subsequent block and it is not to be charged from the students admitted in the academic year 2022-23 on actual basis.
- iv. As per section 11 (2) of the Act, the fees indicated in **Annexure-I** to this order include all types and kinds of fees such as Tuition fees, Library fees, Laboratory fees, Computer Fees, Caution Money, Gymkhana, Internet, Sports and Recreation, Self/Personality Centers fee, University Affiliation fees (if any) and the like. As such the institution shall not collect any other fee from the students except the fees as mentioned in **Appendix-I** to this order.



- v. The fee structure stated above is subject to any direction, circular, orders or notification that may be issued by the Government of Gujarat, Government of India, Statutory or Regulatory Body or Any Court of Law with regard to fees to be charged by institutions for the year 2023-24, 2024-25 and 2025-26 or for any other period that may be prescribed by it.
- vi. The institution shall not take fees for the full course at the time of admission. The fees shall be collected per semester or term of 6 (Six) months as the case may be.
- vii. The institution shall not ask for any bank guarantee or security of any kind from students or their parents.
- viii. The institution shall not compel any student to avail any facility including hostel and transport as a part of the condition for admission or its continuity till the end of the full tenure of the course.
- ix. The institution shall notify the Fee structure on its Notice Board and also display copy of this order on its Mandatory Disclosure Link on its official website.
- x. Additional fees charged from the students admitted under the NRI Quota shall be credited to a separate bank account and the same will be used only for the benefits of the students belonging to the economically weaker class and/or for increasing/developing infrastructure facilities. The institution shall also furnish all the information pertaining to the utilization of excess fees from the NRI category students in the information memorandum which may be submitted along with the fee proposal for next block of three years.
