# FINAL ORDER DATED: 31.8.2018

- Silvergreen Secondary and Higher Secondary English School, Vidyanagari Campus, Motipura Bypass Road, Himmatnagar, District-Sabarkantha has filed its proposal for fixation of fees structure for the academic year 2017-18 along with all relevant documents. After considering the said proposal as well as the documents attached therewith, the Committee has passed an order on 24.05.2018 determining provisional fees for Secondary and Higher Secondary (Science) (GSEB English Medium) for the academic year 2017-18.
- 2. On receipt of the provisional order, the school management has raised its objections vide letter dated 6.6.2018 stating therein that the committee has considered the provisional fees for the academic year 2017-18 with 5% rise therein for the academic year 2018-19 which is not agreeable to the school because the school is providing all facilities as quality education,

good infrastructure, spacious playground, digital class, extra curricular activity, trained and experienced teachers, computer education in lab, science lab, math lab, CCTV Camera, AC class rooms, library facility, etc. To maintain all these facilities, the school requires adequate fees and it is practically impossible for the school to provide all these facilities by collecting fees as provisionally determined by the committee. It is further stated that the school has to give dearness allowance and increment to all staff. The school has to maintain its building and incur all necessary expenses. Due to all these reasons, the fees as proposed by the school may be approved.

- 3. As a matter of fact, the school management has proposed fees for academic year 2017-18 and in its objections request was made for determination of provisional fees even for the academic year 2018-19. Along with the submissions, the school management has also filed provisional accounts for the year ended on 31.3.2018. While looking at the details furnished by the school management along with its letter dated 21.06.2018, it appears that the total income during the academic year 2017-18 was Rs.9,10,800/- and total expenditure for the very same year was Rs.11,05,273/-. The number of students for secondary standard was 31 and the fees charged by the school was Rs.28,800/- for Std. 9 and Rs.30,000/- for Std. 10. The school building and land is owned by Vishwamangal Kelvani Mandal Trust and the land on which the school building is constructed by the trust is also owned by the trust. The school is paying rent to the trust and during the academic year 2017-18, the school has paid rent of Rs.1,80,000/- to the trust.
- 4. At the time of hearing of objections, the Ld. Representatives appearing for the school management has made very clear that they have grievance only against the provisional fees determined by the committee for secondary standards and they have no grievance against the provisional fees determined by the committee for higher secondary standard. Since the school management has collected fees for the academic year 2017-18 at Rs.28,000/- for Std. 9 and Rs.30,000/- for std. 10, the request was made to increase the said fees to the extent of the fees actually collected by the school management. However, looking to the details of expenditure furnished by the school management along with its letter dated 26.6.2018,

the total expenses were shown as Rs.19,28,027/- and income was shown at Rs.9,15,653/-. Thus, there was excess of expenditure of Rs.10,12,374/- over the income. The school management has however claimed Rs.9,73,812/- by way of interest expenses which are not allowable.

- 5. Considering the above facts and circumstances as well as the proposal and all relevant documents, the committee is of the view that the fees proposed by the school management are on the higher side. However, in absence of any relevant details at the time of determination of provisional fees the fees provisionally determined appear to be little less and hence, the same are required to be suitably increased. The committee therefore, determines the final fees for the academic year 2017-18 at Rs.28,000/- for Secondary Standard with 5% rise in the fees for the academic year 2018-19 and 2019-20. Since the school management has no grievance against the provisional fees determined by the committee for higher secondary standard, the final fees also remain the same as was determined by the committee for higher secondary standard.
  - 6. The Committee therefore, determines the final fees for the academic year 2017-18 are as under:

### Terms and conditions:

- 1. The school is not permitted to collect fees for the first quarter of 2018-19, more than fees determined for the year 2017-18.
- 2. The school is permitted to charge fees for the academic year 2018-19 by giving rise of 5% in the final fees determined by the committee for the year 2017-18.
- 3. It is further made clear that the school is not permitted to collect fees under any other head including under the head of Admission Fees or term fees and thereby causing extra burden on the students.

4. Any violation of this order shall be dealt with by the Committee in accordance with law, on

being brought to the notice of the Committee by any aggrieved party.

5. If the school management has any grievance against the final fees determined by the committee, it shall have a right to file revision before the Fees Revision Committee within three weeks from the date of receipt of the order and after making payment of Rs.10,000/by way of filing fees.

6. The school is directed to place the order determining final fees on its notice board as well as

on its website.
